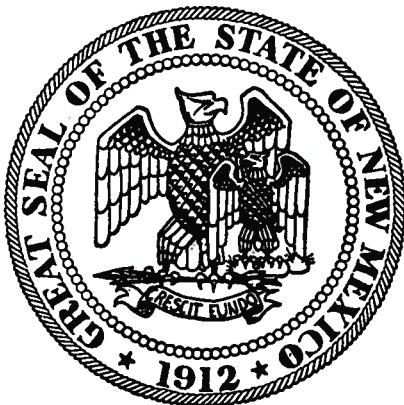

AN ACT

2 MAKING AN APPROPRIATION TO INCREASE HEALTH CARE COVERAGE FOR
3 NEW MEXICANS.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

6 Section 1. APPROPRIATION.--

7 A. Thirty-two million five hundred thousand
8 dollars (\$32,500,000) is appropriated from the general fund
9 to the human services department for expenditure in fiscal
10 years 2009 and 2010 as follows:

11 (1) ten million dollars (\$10,000,000) to
12 provide coverage for individuals enrolled in or eligible for
13 the developmental disabilities medicaid waiver program;

14 (2) twenty million dollars (\$20,000,000) to
15 provide health care coverage for individuals through age
16 eighteen in medicaid or state children health insurance
17 program designed to reduce the number of children without
18 coverage; and

19 (3) two million five hundred thousand
20 dollars (\$2,500,000) for ~~direct~~ behavioral health services to
21 individuals through age eighteen with behavioral health care
22 needs in medicaid or state children health insurance program, ~~BL~~

23 ~~provided no amount of the appropriation in this paragraph~~ ~~BL~~

24 ~~shall be used for administration of the programs~~ ~~BL~~
