SENATE EXECUTIVE MESSAGE NO. 49

Dear President Pro Tempore Jennings and Members of the Senate:

Pursuant to the Constitution of the State of New Mexico, Article IV, Section 22, I hereby VETO and am returning SENATE BILL 124, enacted by the Fiftieth Legislature, First Session, 2011

This bill prohibits motorists from passing a bicycle when there is less than five feet of space between the vehicle and the bicycle.

Current law already provides penalties for careless driving. NMSA § 66-8-114(B) states that, "Any person who operates a vehicle in a careless, inattentive or imprudent manner, without due regard for the width, grade, curves, corners, traffic, weather and road conditions and all other attendant circumstances is guilty of a misdemeanor." I feel existing law already addresses the criminality of endangering cyclists in our state.

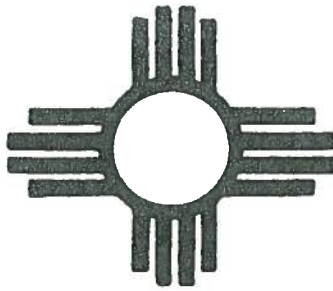

1 AN ACT

2 RELATING TO MOTOR VEHICLES; PROVIDING THAT A MOTORIST MUST
3 PASS A BICYCLIST WITH AT LEAST A FIVE-FOOT DISTANCE;
4 ESTABLISHING A PENALTY ASSESSMENT MISDEMEANOR.

5
6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

7 SECTION 1. A new Section 66-7-374 NMSA 1978 is enacted
8 to read:

9 "66-7-374. APPROACHING OR PASSING BICYCLIST.--A driver
10 of a motor vehicle shall proceed with caution when
11 approaching or passing a person on a bicycle and shall pass
12 the bicyclist at a reasonable speed and keep a safe distance
13 from the bicyclist; provided that in no event shall a
14 distance of less than five feet be considered a safe distance
15 within the meaning of this section, and provided further that
16 the motorist shall not pass the bicyclist if the requirements
17 of this section cause the motorist to cross the center line
18 of the road when there is a vehicle approaching in the
19 opposite direction, but a motorist may cross the center line,
20 notwithstanding the provisions of Section 66-7-315 NMSA 1978,
21 if allowing the requisite five feet requires the motorist to
22 cross the center line and there is no oncoming traffic."

23 SECTION 2. Section 66-8-116 NMSA 1978 (being Laws 1978,
24 Chapter 35, Section 524, as amended) is amended to read:

25 "66-8-116. PENALTY ASSESSMENT MISDEMEANORS--

1 DEFINITION--SCHEDULE OF ASSESSMENTS.--

2 A. As used in the Motor Vehicle Code, "penalty
3 assessment misdemeanor" means violation of any of the
4 following listed sections of the NMSA 1978 for which, except
5 as provided in Subsections D and E of this section, the
6 listed penalty assessment is established:

1 misdemeanor elects to accept a notice to appear in lieu of a
2 notice of penalty assessment, a fine imposed upon later
3 conviction shall not exceed the penalty assessment
4 established for the particular penalty assessment misdemeanor
5 and probation imposed upon a suspended or deferred sentence
6 shall not exceed ninety days.

7 D. The penalty assessment for speeding in violation
8 of Paragraph (4) of Subsection A of Section 66-7-301 NMSA
9 1978 is twice the penalty assessment established in
10 Subsection A of this section for the equivalent miles per
11 hour over the speed limit.

12 E. Upon a second conviction for operation without a
13 permit for excessive size or weight pursuant to Section
14 66-7-413 NMSA 1978, the penalty assessment shall be two
15 hundred fifty dollars (\$250). Upon a third or subsequent
16 conviction, the penalty assessment shall be five hundred
17 dollars (\$500)."

18 SECTION 3. EFFECTIVE DATE.--The effective date of the
19 provisions of this act is July 1, 2011. _____
