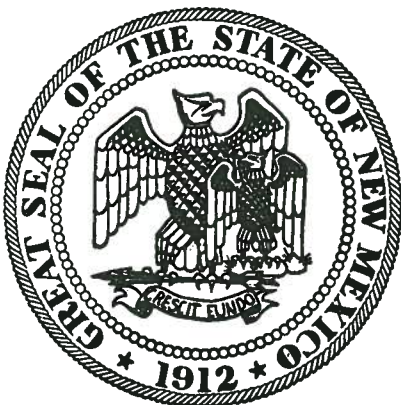

EMERGENCY CLAUSE

CHAPTER 6

AN ACT

1
2 RELATING TO FLEXIBILITY FOR PUBLIC SCHOOLS; MAKING AN
3 APPROPRIATION FROM THE PUBLIC SCHOOL CAPITAL OUTLAY FUND TO
4 PAY FOR PROPERTY INSURANCE ON BEHALF OF SCHOOL DISTRICTS AND
5 CHARTER SCHOOLS DURING FISCAL YEAR 2010; DECLARING AN
6 EMERGENCY.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

9 Section 1. APPROPRIATION--PUBLIC SCHOOL CAPITAL OUTLAY
10 FUND FOR INSURANCE COVERAGE.--Notwithstanding the provisions
11 of the Public School Capital Outlay Act, twenty-nine million
12 dollars (\$29,000,000) is appropriated from the public school
13 capital outlay fund to the public school insurance authority
14 for expenditure in fiscal year 2010 for the purpose of
15 reimbursing or paying property insurance premiums on behalf
16 of school districts and charter schools. Of the
17 appropriation, the amount necessary to reimburse or pay up to
18 seven million dollars (\$7,000,000), for property insurance
19 coverage in fiscal year 2010 for the Albuquerque public
20 school district, shall be distributed by the public school
21 insurance authority to the Albuquerque public school
22 district. Any unexpended or unencumbered balance remaining
23 at the end of fiscal year 2010 shall revert to the public
24 school capital outlay fund.

25 Section 2. EMERGENCY.--It is necessary for the public
