AN ACT

2 RELATING TO COURTS; CREATING AN ADDITIONAL JUDGESHIP IN THE
3 EIGHTH JUDICIAL DISTRICT.
4

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

6 SECTION 1. Section 34-6-11 NMSA 1978 (being Laws 1968,
7 Chapter 69, Section 14, as amended) is amended to read:

8 "34-6-11. JUDGES--EIGHTH JUDICIAL DISTRICT.--There
9 shall be three district judges in the eighth judicial
10 district. At least one of the judges shall maintain the
11 judge's principal office in Colfax or Union county and at
12 least one of the judges shall maintain the judge's principal
13 office in Taos county.

14 SECTION 2. TEMPORARY PROVISION--DISTRICT JUDGE--
15 APPOINTMENT.--The additional district judgeship provided for
16 in this act shall be filled by appointment by the governor
17 pursuant to the provisions of Article 6 of the constitution of
18 New Mexico.

19 SECTION 3. EFFECTIVE DATE.--The effective date of the
20 provisions of this act is July 1, 2011. _____


