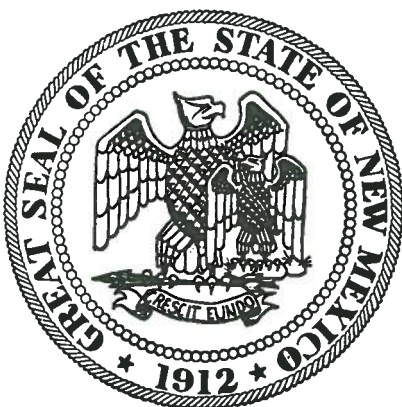

Chapter 94

AN ACT

RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE;
REQUIRING NOTICE OF THE EXPIRATION OF PUBLIC WORKS CONTRACTOR
REGISTRATION; PROVIDING FOR BIENNIAL REGISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 13-4-13.1 NMSA 1978 (being Laws
2004, Chapter 89, Section 1, as amended) is amended to read:

"13-4-13.1. PUBLIC WORKS CONTRACTS--REGISTRATION OF
CONTRACTORS AND SUBCONTRACTORS.--

A. Except as otherwise provided in this
subsection, in order to submit a bid valued at more than
sixty thousand dollars (\$60,000) in order to respond to a
request for proposals or to be considered for award of any
portion of a public works project greater than sixty thousand
dollars (\$60,000) for a public works project that is subject
to the Public Works Minimum Wage Act, the contractor, serving
as a prime contractor or not, shall be registered with the
division. Bidding documents issued or released by a state
agency or political subdivision of the state shall include a
clear notification that each contractor, prime contractor or
subcontractor is required to be registered pursuant to this
subsection. The provisions of this section do not apply to
vocational classes in public schools or public post-secondary
educational institutions.


1 B. The state or any political subdivision of the
2 state shall not accept a bid on a public works project
3 subject to the Public Works Minimum Wage Act from a prime
4 contractor that does not provide proof of required
5 registration for itself.

6 C. Contractors and subcontractors may register
7 with the division on a form provided by the division and in
8 accordance with workforce solutions department rules. The
9 division shall charge a registration fee of four hundred
10 dollars (\$400) every two years. The division shall issue to
11 the applicant a certificate of registration within fifteen
12 days after receiving from the applicant the completed
13 registration form and the registration fee.


14 D. No less than thirty days before the expiration
15 of a registration certificate, the division shall mail or
16 electronically transmit to a registrant's address as
17 reflected in the files of the division a reminder of the
18 approaching expiration date.

19 E. Registration fees collected by the division
20 shall be deposited in the labor enforcement fund." _____


