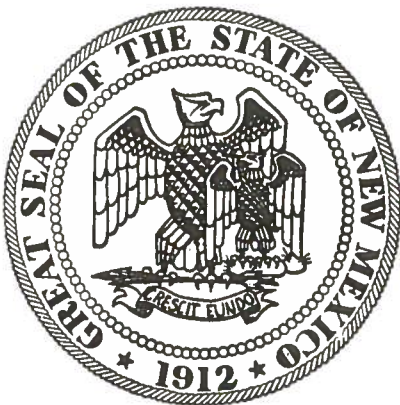

2 RECOGNIZING THE OUTSTANDING CONTRIBUTIONS OF THE LOVINGTON  
3 MASONIC LODGE NUMBER 46 TO THE LOVINGTON COMMUNITY, LEA COUNTY
