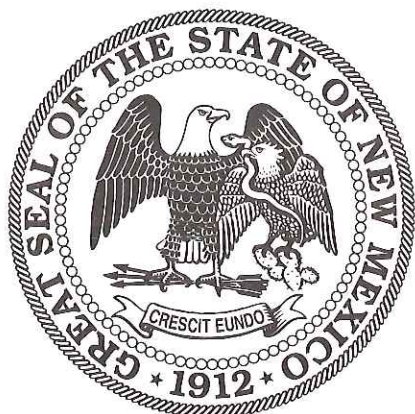

1 A MEMORIAL

2 RECOGNIZING THE PARTNERSHIP OF THE GLOBAL EMBASSY OF
3 ACTIVISTS FOR PEACE, THE UNIVERSITY OF NEW MEXICO DIVISION OF
4 STUDENT AFFAIRS, THE UNIDOS PROJECT AND LEARNING ALLIANCE NEW
5 MEXICO TO DEVELOP THE FIRST INTERNATIONAL ALLIANCE OF
6 UNIVERSITIES FOR PEACE IN THE UNITED STATES.

8 WHEREAS, the global embassy of activists for peace works
9 with universities across the world to develop programs and
10 services to promote peace through the international alliance
11 of universities for peace; and

12 WHEREAS, the university of New Mexico is recognized in
13 the United States as a research university that serves
14 Hispanics, and its mission is to train professionals in the
15 different branches of knowledge and practice; and

16 WHEREAS, the global embassy of activists for peace and
17 the university of New Mexico have joined in partnership to
18 develop the first international alliance of universities for
19 peace in the United States; and

20 WHEREAS, the global embassy of activists for peace, the
21 university of New Mexico division of student affairs, the
22 unidos project and learning alliance New Mexico have agreed
23 to begin the planning stages to establish a partnership model
24 to be formalized in the summer of 2018;


25 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF

1 REPRESENTATIVES OF THE STATE OF NEW MEXICO that the
2 partnership of the global embassy of activists for peace, the
3 university of New Mexico division of student affairs, the
4 unidos project and learning alliance New Mexico be recognized
5 for the development of the first international alliance of
6 universities for peace in the United States; and

7 BE IT FURTHER RESOLVED that copies of this memorial be
8 transmitted to the executive president of the global embassy
9 of activists for peace, the president of the university of New
10 Mexico, a representative of the unidos project and the
11 executive director of learning alliance New Mexico. _____
